Under our Mental Health license, we provide Partial Care Services for clients enrolled in Medicaid and in the Behavioral Health Initiative.

Under our Substance license, we provide Partial Care, I.O.P and Outpatient Services for clients enrolled in the Work First New Jersey program or in the Division of Addiction Services: Substance Abuse Initiative (SAI) and Drug Court programs.

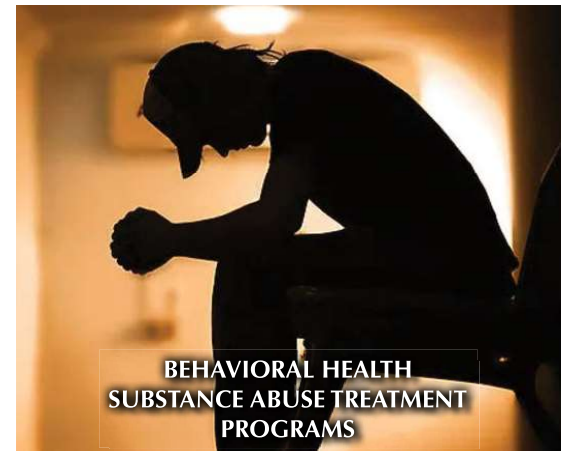

TRANSPORTATION

FOOD PROGRAM

CPI contracts with the Community Food-Bank of NJ and Sodexo Marriott Food Services to provide nutritious breakfast and lunch with optional entrees.

MEDICAL SERVICES:

Behavioral Health: CPI has a medical team comprised of a psychiatrist and psychiatric nurses who provide:

- psychiatric assessments
- medication management
- medication education and counselling

Physical Health: CPI affiliates with a local physicians group that provides medical services at CPI to those clients who wish to participate.
