



Program Overview

Community Creche Expansion Program (CCEP) provides transitional housing, substance abuse treatment and services for women and their children. *CCEP* is funded by the US Department of Health and Human Services, Substance Abuse and Mental Health Services Administration (SAMHSA).

Goal: The purpose of the program is to expand and enhance our current continuum of care for pregnant, postpartum women and their children. *CCEP* will provide culturally relevant, evidence based co-occurring substance abuse/mental health /trauma treatments, and recovery supports to women who have limited access.

Target Population: Essex County pregnant and postpartum (child under the age of 1) women in need of substance abuse treatment. Children (ages 17 and under) may accompany mom while in treatment.

Services: The program identifies women in need of substance abuse treatment and provides them with comprehensive case management, linkages to social services and health care, counseling and health education utilizing evidence based curricula and practices.

- Counseling (Motivational Enhancement Therapy, Family Behavioral Therapy, Seeking Safety and group therapy)

- Must be an Essex County Resident
- Must be pregnant or diagnosed as post-partum (if postpartum, must have at least one child under 12 months)
- Must be 18 years of age or older
- Must be in need of substance abuse treatment
- Classified as low-income
- Must complete a pre-screening questionnaire

- Debe ser residente del Condado de Essex
- Debe estar embarazada o diagnosticada como puérpera (si es puérpera, debe tener al menos un hijo menor de 12 meses)
- Debe ser mayor de 18 años
- Debe necesitar tratamiento por abuso de sustancias
- Clasificada como de bajos ingresos
- Debe completar un cuestionario de preselección
